- a) Proof of age
 - b) Marks sheet of class X or any equivalent examination along with certificate of conversion of Grade/GPA into percentage.
 - c) Marks sheet of class XII or any equivalent examination along with certificate of conversion of Grade/GPA into percentage.
 - d) Marks sheet of Bachelor's degree or equivalent degree along with certificate of conversion of CGPA into percentage. (in case of admission to P.G. program)
 - e) Copy of the valid passport of parent working abroad
 - f) Copy of valid working visa / work permit/license to work of parent (duly translated in English and self-attested)
 - g) Copy of valid Residence permit/Iqama (duly translated in English and self-attested).
 - h) Letter from the employer of the parent abroad (not older than 6 month at the time of admission)
 - i) NRI Status Certificate issued by the Indian Embassy in the concerned country (not older than 6 months at the time of admission)
 - j) Affidavit on Rs. 10 stamp paper from the parent for financial support (can be submitted at the time of final admission).
