NOTIFICATION

The Executive Council, JMI, in its meeting held on 30.06.2026, on the recommendations of the *Majlis-i-Talimi* (Academic Council) in its meeting held on 23.06.2026, has approved the following amendments to the Ordinance - 15 (XV) (Academic) 'University Examinations: General Guidelines' pertaining to compartment examinations, with immediate effect:

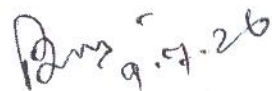

23.1 (i) Any candidate, intending to apply for re-evaluation of answer scripts (s) of any Course/Subject of his/her written Examination, may do so on the prescribed Application Form within 15 days from the date of issue of marks sheet.	23.1 (i) Any candidate, intending to apply for re-evaluation of answer scripts(s) of any Course/Subject of his/her written Examination, may do so on the prescribed Application Form within 15 days from the date of issue of marksheet (except final year).
(ii) The re-evaluation of scripts will not be allowed in more than one-third of written Papers of an Annual Examination.	(ii) The re-evaluation of scripts will not be allowed in more than one-third of written Papers of an Annual Examination (except final year).
	Final year students may apply to appear in compartment exam directly.
24.4 There will be no Compartment Examination in the programmes where "Carry Over System" is in operation. However, candidates failing in the final year/final two semesters of any programme/course, may be allowed to appear in the Compartment Examination which will be held after the final (last) annual / final (last) semester-end examination. The date(s) of such examinations will be notified by the Controller of Examinations.	24.4 There will be no compartment examination in the programs where 'Carry Over System' is in operation. However, only final semester (final year candidates of annual mode programs) candidates <u>having backlog paper in any of the semester/year of any course of the program of IMI (excluding distance mode programs)</u> may apply to appear in the compartment examination which will be held after the final (last) annual / final (last) semester end examinations. The date(s) of such examinations will be notified by the Controller of Examination.
